- Positive results cannot be guaranteed. Willsallen Veterinary Services can accept no responsibility for the quality of semen, or its disease or genetic status.
- The Donor mare will be placed in a crush and be examined internally on multiple occasions, causing a small but finite risk of injury, infertility or death.
- Reproductive hormones, sedatives and relaxants will be used at our discretion, at owner's expense.
- The mare will be wormed and have her feet trimmed at our discretion, at owner's expense.
- Willsallen Vet Services and staff will take all care and provide attention and service to your horse while they are at the breeding centre. However, problems such as sickness, injury and lameness may occur. In the event that you cannot be contacted regarding unforeseen problems WVS will treat the animal as required. The client is responsible for any costs that may be associated.
- All recipient mares remain the ownership of Willsallen Veterinary Services, all expenses they incur when in your care remain your responsibility.
- All recipient mares must be returned to Willsallen Vet Services premises before August the year the foal is weaned, failure to do so and if the mare is not in good health will incur a replacement fee of \$500.

UNLESS OTHERWISE AUTHORISED, ALL ACCOUNTS MUST BE SETTLED ON COLLECTION OF YOUR MARE IF NOT BEFORE
